No. GDP 16/2008/4 : Whereas Government in the Department of Welfare of Plain Tribes and Backward Classes vide Order No. TAD/BC/79/2008/13 Dated 26-05-2008 , letter No. TAD/B.C./79/2008/55 Dated 27-06-08 and letter No. TAD/BC/2008/38 Dtd. 5-9-08 have authorized the Deputy Commissioners of Goalpara and Kamrup to re-examine the issue of delimitation of the Rabha Hasong Autonomous Council (RHAC) afresh and submit proposal to the Govt. for approval and notification ; now, therefore, in exercise of the authority conferred upon the undersigned, the Draft Delimitation proposal is hereby published on this 10th day of Sept. 2008 proposing a total of 387 numbers of villages covered under the Revenue Circles of Rongjuli, Dudhnoi, Matia, Balijana and Lahkipur in the district of Goalpara for inclusion into RHAC area.

Copies of the Draft Delimitation proposal will be available for inspection by the public in the office of the Deputy Commissioner, Goalpara / Circle Officers, Rongjuli, Dudhnoi, Matia, Balijana and Lahkipur Revenue Circles /Office of the Block Development Officer, Rongjuli, Kuchdhowa, Krishnai, Matia, Balijana, Kharmuza, Lahkipur and Jaleswar /Principal Secretary, Rabha Hasong Autonomous Council, Dudhnoi/ all Gaon Panchayat Offices of the district . Necessary application form for inclusion and exclusion will also be available at the above mentioned offices. Photo copy / Typed copy of application form can also be used for the said purpose.

Claims from individuals/organizations etc. for inclusion/exclusion on the Draft Delimitation proposal will be received only in the office of the Deputy Commissioner, Goalpara and Circle Officers, Rongjuli, Dudhnoi, Matia, Balijana and Lahkipur Revenue Circle Office on working days and working hours from 10-9-08 to 30-9-08.

Date of hearing on objections/suggestions so received shall be fixed at a later stage, if necessary.
