In pursuance of W.T Message vide No.DS.58/2017/PT/214 Dated 29-01-2020 received from the Director, Food, Civil Supplies & consumer Affairs, Assam, Guwahati and subsequent online allocation order No.RALLOC032020, the monthly online allocation is made for the month of **MARCH, 2020** under NFSA/13. The last date of value deposit and lifting of allotted rice for the month of **MARCH, 2020** is **31-03-2020**. The allotted rice to be distributed @ 5.00 K.g per head per month to each member of the Priority card holder and @ 35.00 K.g. per month to the AAY card holder. The Rice allotted to the Tea garden beneficiaries will be provided at free cost whereas other than TEs the rice will be provided @ Rs.1/- per Kg. to the beneficiaries.
