ORDER

In pursuance of Govt. Notification No. ASE.01/2020/Pt-V/9, dtd. 05/05/2021 issued by Additional Secretary to the Govt. of Assam, Secondary Education Department and in view of the increasing number of COVID cases in the Goalpara District, I Smt. Varnali Deka, IAS, Deputy Commissioner cum Chairperson, District Disaster Management Authority (DDMA), Goalpara, do hereby direct that all Educational Institutions (Government and Non-Government) from Pre-primary section to University level along with Hostels and Coaching Institutions will remain closed from 6th May/2021 onwards until further orders. However, online classes have to be made available for the students.

The attendance of the office section of the educational Institutions will be guided by the directives issued by District Disaster Management Authority (DDMA) vide order No. DDMA/Goalpara/37/2020/180-183 Dated: 4th May/2021.
