## NOTICE inviting Quotations

Quotations are invited from registered reputed firms/Suppliers having prior experience for following items for installation of computerized registration & cash counter at 200 Bedded Civil Hospital, Goalpara by District Health society, Goalpara.

Description of the items required:

1. Server machine : 4<sup>th</sup> Gen Intel core i7, 8GB RAM, 300 GB HDD, Windows 7.
2. Desktop computer: Intel quad core, 4GB RAM, 300 GB HDD, Windows 7
3. Dot matrix printer
4. Online UPS (1KVA) With battery pack (65 Ah x 3nos) (Preferably Numeric )
5. Offline UPS (1 KVA)
6. Set up & installation of LAN Facility.

Rates of the items should be mentioned clearly along with name of company in the quotation submitted by the bidder against each item.

Quotations have to be submitted at the office of the Jt. DHS, Goalpara on or before 05-09-15 till 4:00 p.m. The work should be completed within 10 (five) days from the allotment of the work. Tax will be deducted from the party as per Assam Govt. norm. The lowest price bidder will be selected for the same and all details will be provided by the undersigned to the selected bidders. The undersigned reserves all rights to accept or reject any or all the tender without assigning any reason thereof.

The quotationers will have to follow the following clauses and terms and conditions.

**Clause:**

- 1) The quotationers shall have to furnish one photostat copy of Registration Certificate/ VAT/Income Tax Clearance Certificate.
- 2) Bidder shall have atleast 1 successful installation in last 2years in similar projects- Completion certificate/ Work experience certificate to be furnished.
- 3) The rate should be quoted including of all taxes with prices item wise and brand proposed.

**Terms and Condition:**

- 1) The Contract of Successful quotationers may be cancelled at any time without prior notice and assigning any reason thereof for not maintaining the clause. The Society is not bound to accept the lowest rate of any quotationer.
- 2) The successful quotationer shall have to deliver the items within the stipulated time.
