- 1. The Quotation should be accompanied with up-to-date clearance certificate i.e. income tax, Trade License and GST IN etc. with their quotation.
- 2. The printing press should be registered with Printing and Stationary Department, Govt. of Assam (Copy of registration certificate should be furnished).
- Self attested copies of records/documents relating to registration of PAN, up to date income tax clearance certificate ,trade license and GST IN etc should be furnished .Quotation submitted without self attested copies of all certificate will be rejected.
- 4. The quotation should also mention about the resources of the press viz- nos of printing machines, capacity of its computers etc.
- 5. Record and Documents in support of experience in Govt. works to be furnished.
- 6. Rate(s) should be inclusive of all taxes and admissible taxes like GST/Income Tax as applicable will be deducted at source from the bill amount.
- 7. Quantity of works to be printed as per requirement from time to time.
- 8. If any Printing press fails to complete printing works within the stipulated time the work order will immediately be withdrawn from the concerned firm.
- 9. The rates accepted will be treated as final and alteration or modification will not be entertained for any circumstances for any reason whatsoever and it will remain valid until next quotation is called for.
- 10. Authority is not bound to accept the lowest rate or any quotation and reserves the right to accept /reject any quotation without notice and assigning any reasons thereof.
