- The suppliers who have already failed/surrendered their rates against items relating to Tender Notice issued vide No. GDM.8/2019/64-65, dated-04/05/2020 shall not be considered.
- The rate quoted shall remain valid for 1 (one) year from the date of acceptance.
- 5. Any over writing/ cancellation on the quotation paper shall not be entertained.
- The bidder must have a standing Shop/ Godown of his/her own in Goalpara district and must have a valid local trade
- The bidder should have at least 2 (two) years experience in supply of the relief materials. 7.
- 8. Rate against each item should be clearly written both in figure and words against the specified quantity.
- Rate should be quoted inclusive of all taxes i.e. GST etc.
- Rate of the items should not be more than the printed MRP.
- 11. The Suppliers should mention the brands of the item which will be supplied at quoted price compulsorily.
- It is not binding of the undersigned to accept the lowest rate.
- Sample of materials must be supplied with quotation.
- 14. The undersigned reserves the right to accept or reject any or all quotations without assigning any reason thereof.
- 15. Items are to be supplied within 2 (two) hours after receipt of indent, failing which the indent will be issued to the next bidder for a particular item at L1 rates.
